

# MENTAL HEALTH EUROPE IS LOOKING FOR A DIRECTOR

Mental Health Europe (MHE) is recruiting a Director for its secretariat in Brussels.

Purpose of job: To design, develop and lead the implementation of the organisational strategy of MHE in line with the vision and mission of the organisation.

## The function includes the following responsibilities:

- Implementation as Chief Executive Officer of the organisation's strategy: Preparing, monitoring, reporting and coordinating the agreements, work programmes and projects
- Managing the employed staff
- Preparing and managing the annual budgets
- Planning and coordinating the organisation of events, policies and activities
- Working with, providing organisational support and reporting to the Board, which is elected from the membership
- Working with the Executive Committee
- Representing and promoting Mental Health Europe towards external actors
- Representing Mental Health Europe at conferences and meetings
- Developing funding strategies towards a solid financial base
- Developing and supporting the MHE membership
- Everyday financial and administrative management

## Requirement for the position:

#### **QUALIFICATIONS**

It is essential that candidates be of graduate calibre. A qualification to degree level or equivalent involving social science, health, public administration, law or other relevant discipline is desirable.

#### **EXPERIENCE**

- Experience in the mental health field as a practitioner, policy maker or advocate is highly desirable.
- Experience of working for a regional, National or international NGO is desirable.
- Experience of working with public authorities and other stakeholders at a very senior level is essential.
- Experience in commissioning research is desirable.
- Experience in management is essential.
- Experience of project delivery is highly desirable.
- Experience of managing an alliance/network is highly desirable.

#### KNOWLEDGE

- Understanding of the development and implementation of EU-wide policies, strategies and systems is desirable.
- Knowledge of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) is highly desirable and understanding of and commitment to the social/human rights model of disability is essential
- A wide-ranging understanding of mental health issues (including recovery, human rights and the need for the transition from institutional to community-based services) is essential.

- An understanding of the policy process and of the main institutions, agencies and social structures relevant to mental health, human rights and social justice in Europe is desirable.
- Understanding of and commitment to the psychosocial model of mental health, including the principles of "recovery" within mental health is essential.
- An understanding of the principles and practice of quality management is desirable.

#### SKILLS/QUALITIES

- Will be able to demonstrate high levels of communications skills; leadership; analysis and planning; negotiation; project management; change management; the line management of staff.
- Will have excellent presentational and public speaking skills.
- Must be able to communicate clearly in writing and present complex information and arguments with similar clarity.
- Must be approachable, supportive, able to work on own initiative and as a member of a team.
- Computer literacy is essential.
- Must be able to communicate fluently in English.
- Communication skills in other languages (particularly French and/or Dutch) is desirable.
